





SOON, ASSESS YOUR PROPERTY TAX WITH NEW SOFTWAREIN LUCKNOW

As of now, people have to fill a self-assessment form that is scrutinised by the taxation officer of the area and the tax amount is generated.

A software being prepared by NIC will enable people to determine their property tax without manual intervention; thus reducing the chances of corruption. The new software will provide services like self-assessment of property tax of house, shop and property tax return. It will collect/record all information of properties within a jurisdiction, calculate the tax at prescribed rates and levy and collect tax in a transparent manner



RESIDENTIAL REAL ESTATE IN DEMAND, HOME PRICES UP WITH MUMBAI, BENGALURU LEADING THE MARKET

Residential prices are supported by increase in sales owing to realisation of need for housing among homebuyers, relatively lower interest rates and a quick rebound in economic activity post the waves of Covid-19 pandemic. Housing prices have grown in year-on-year terms during the first half of 2022 for the first time since the second half of 2015.

Knight Frank India report suggests in terms of price increase, Mumbai and Bengaluru led the price increase with 9 percent rise each. NCR, Pune recorded 7 percent rise. Sales registered year on-year growth of 60 percent in the first half of 2022

CONSTRUCTION INDUSTRY TRENDS & INNOVATIONS IN 2022

Offsite Construction:- Offsite construction, one of the emerging construction industry trends, allows designing, manufacturing, and fabricating building elements in a factory. In traditional construction, weather conditions increase costs by introducing contingency fees and require extra labor hours. Onsite construction also produces a lot of material waste. Offsite construction, on the other hand, transforms the construction lifecycle in terms of sustainability, worker safety, and quality. It incorporates a range of innovative materials, 3D printing technology, and novel assembling techniques.

The first part of offsite construction involves volumetric construction which includes modular and pod construction. This technique allows the prefabrication of heavy 3D structures like rooms and homes. The second aspect includes panelized construction under which the factory develops flat panels for use in walls, floors, or roof panes. Modern commercial buildings use this technique to install partitions and support elements.
