REAL ESTATE IS THE BEST BET AGAINST INFLATION - HERE'S WHY

Historically, real estate has proven to be a stable investment even during inflationary periods. Inflation can, in fact, benefit real estate investors as property rental values increase and existing real estate assets appreciate in value. Property prices tend to increase with inflation partly because of the higher cost of construction materials. Inflation has pushed up the cost of construction materials such as steel and cement, leading to an increase in the price of under-construction properties.

This will also affect the price of existing properties because of the reduced supply of new properties in the market. In inflationary times, there are fewer new properties as builders put their development plans on hold, given the rising input costs. This leads to a fall in property inventory levels, therefore, increasing home prices. Potential buyers can get priced out of buying properties because of the high home prices.



YOU CAN NOW RECOVER GST PAID ON UNDER-CONSTRUCTION PROPERTY IF THE DEAL IS CALLED OFF

Once the finer details are worked out, buyers of underconstruction property will be soon able to reclaim the GST paid on the property directly from the government if the person opts out of th At its meeting on December 17, the Goods and Services Tax (GST) Council made some recommendations that will have wide ramifications. Among other things, it will help a lot of homebuyers, especially those who opt for under-construction properties. The council recommended that the GST rules be amended to allow a buyer to file an application for refund in cases where the contract or agreement for supply of services, like construction of a flat or house, is cancelled and the time period to issue a credit note by the concerned supplier (developer) is overe deal and the time period for the developer to refund the money has expired.

ADVANCED CONSTRUCTION ROBOTICS DEVELOPS REBARTYING ROBOTS

Based out of the US, Advanced Construction Robotics is a startup developing rebar tying robots to automate rebar installation. The startup's TyBot and IronBot solutions perform repetitive and backbreaking tasks of rebar installation using artificial intelligence and computer vision. TyBot eliminates the need for manual mapping and calibration by auto-locating, auto-positioning, and tying up to 110 rebar intersections per hour. IronBot, on the other hand, relieves the burden of the heavy lifting by placing 5,000-pound bundles of both transverse and longitudinal rebar. Hence, it saves schedule time and reduces the risk of injuries as it does not require pre-mapping, programming, and calibration. The startup's solutions increase workforce productivity while keeping them safe.
